## **The Laggan Forest Trust Annual General Meeting.**

This year's AGM will be held on **Monday 3<sup>rd</sup> June 2019 at 7pm in The LAGGAN WOLFTRAX FOREST CENTRE, Strathmashie, Laggan.**

### Election of Trustee Directors:

The Laggan Forest Trust would welcome the nomination of new directors from its membership to help guide our future work in Forestry and Recreational Access.

The meeting will formally seek the adoption of the Trustee's Report, the Annual Financial Statements – both to the end of September 2018, and the Election of Trustee Directors and any questions arising.

The Trust is at a critical stage of its development and the meeting will update members on future potential developments related to potential Forest Acquisition and recent discussions with Forestry and Land Scotland, CNPA and HIE. The directors look forward to hearing and seeking the views of members on these developments.

The minimum number of board members that the Trust requires is five (5). At the date of the AGM we will have 4 members eligible for re-election.

### The current directors are:-

Colin Morgan (member)- Elected February 2017 – retires Feb 2020

Ian Hall (member) - Re-elected March 2018.

Michael Sharp (member) - Elected February 2017 - retires Feb 2020

Kate Christie (co-opted) Elected by co-opting February 2017 - retires at AGM May 2019 - Eligible for re-election.


